Dear Stakeholders,

This is to inform that the above Management Unit under the Parent Company **FGV Holdings Berhad** with RSPO membership number **1-0225-16-000-00** had appointed Intertek Certification International Sdn Bhd to conduct the ~~Initial Certification/Recertification Audit~~ **Surveillance Audit (ASA-02)** at **Bukit Kepayang POM** and its supply base, located at **Pahang, Malaysia**. The audit will be conducted from **10 – 11 November 2025** against the requirements of:

- RSPO Principles & Criteria 2018

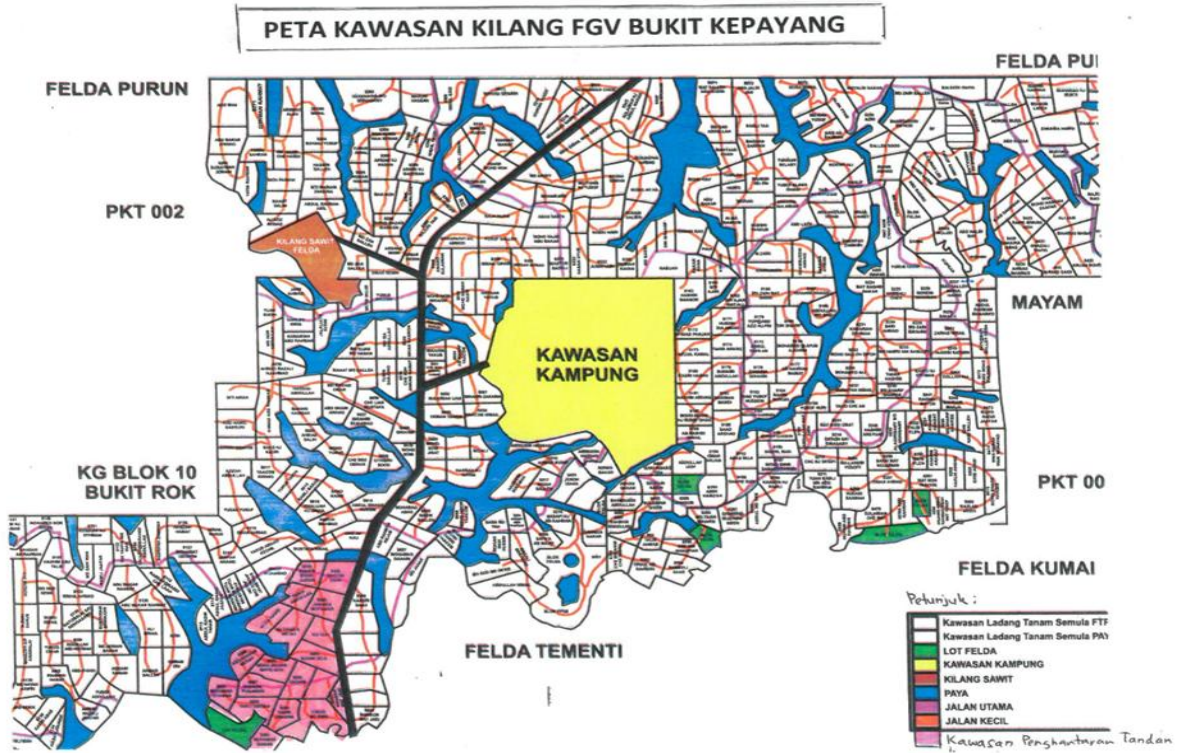

**Location Map of FGV Bukit Kepayang Grouping**

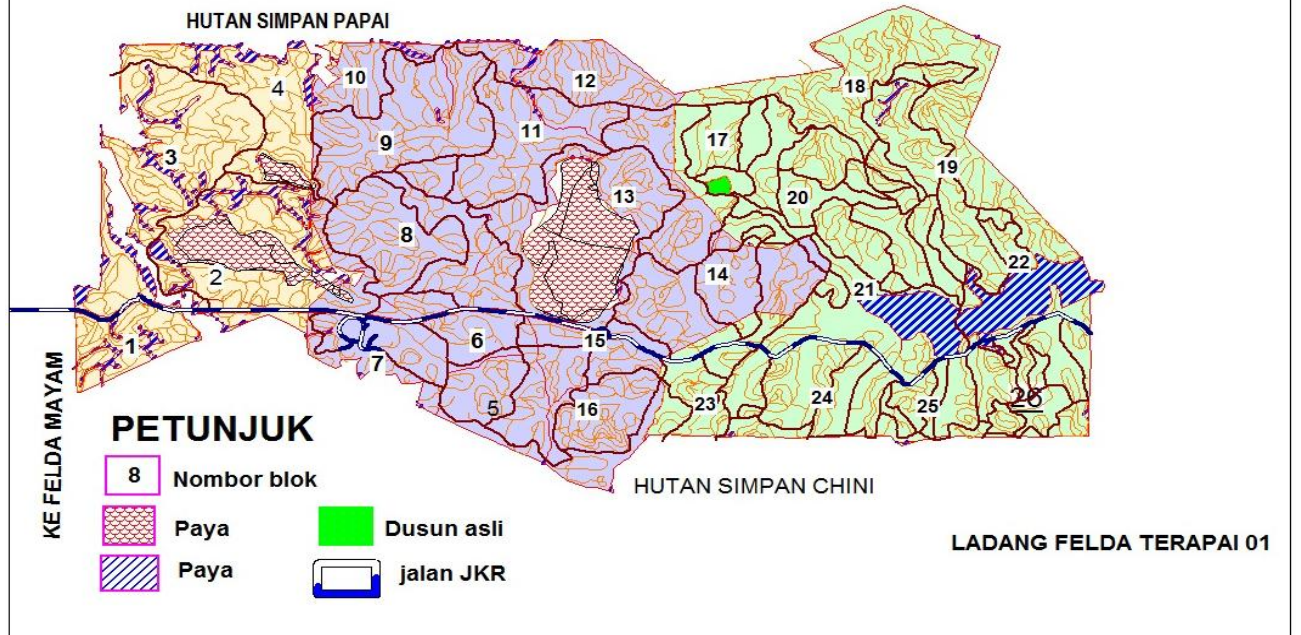
