The below left photos show the counterfeit product have merged the content from several different Point Lighting Corporation labels. For this fixture, Point Lighting Corporation documentation specifies two separate labels be used, one label for English and a second label for French warnings. The counterfeit products have both English and French markings on a single label. Further, they used a portion of the PSF-53005-2 fixture label and a portion of the PSF-53025-2 fixture label. The counterfeit products uses the PSF-53005 fixture part number, but it is missing the "-2" in the full part number "PSF-53005-2". It also utilizes indicates the use of lamps "PAR30S or PAR20" taken from Point Lighting Corporations' PSF-53025-2 nameplate. It also indicates that mounting distance to the ground suitable within "1.4 m (4ft)", rather than "1.2 m (4ft)"
